

# **Community Council Report**

This report covers progress we have made in dealing with your priorities for the Kincardine and Mearns Community Council area for the period 1 to 28 February 2022.

The report aims to highlight emerging issues in your area, provide crime prevention advice and guidance to Community Council members and the residents you represent. Our focus is to reduce crime and disorder, help create safer communities and respond effectively to local concerns.

## **Community Policing Priorities**

### Antisocial behaviour, Violence and Disorder:

There has been a decrease by 30 incidents in the number of Anti-social Behaviour calls within Kincardine and Mearns for the month of February, with 36 calls being received.

There were 13 calls received that related to Youth specific disturbances.

There were 8 Assault crime reports raised within February. 4 that have been reported are detected and have been reported to the Procurator Fiscal. Meanwhile, 4 are still being investigated. 4 of the assaults were domestic related.

### Acquisitive Crime:

There have been 8 Thefts throughout the Kincardine and Mearns area during February. 7 remain undetected and are still being investigated. A theft of note was that of a trailer valued at  $\pounds$ 3,000 which is still being actively investigated.

## Road Safety & road crime:

### **Drink/Drug Driving**

In February there was 1 driver found to be under the influence of alcohol. They have been charged and reported to the Procurator Fiscal for consideration of prosecution.

### **Dangerous Driving**

There was 1 reported incident of dangerous driving for the month of February, which is still under enquiry.

### **Drug Search Warrants**

1 Evidential Search Warrants was executed in the Kincardine and Mearns area for the month of February, a small quantity of drugs was seized and the offender reported.

All instances of illegal drug use should be reported to the Police. Any report will be treated in confidence and be completely anonymous.

### **Community / Neighbour Mediation**

Mediation is one way to resolve disputes between those who live in the same locality or neighbourhood.
