

Harry Fleming is a historian who bought the Bervie Brow site 9 or 10 years ago. Bervie Brow is a Cold War bunker.

Mr Fleming now lives in the guard house and is working to restore the bunker for its historical interest, and to enhance the sites natural environment.

The bunker is probably the biggest civil engineering project in the CKDCC area. It was built between 1951 and 1953, the same period as "Scotland's Secret Bunker" in Fife. The bunker goes down to a depth od 150 ft below ground level and is in good condition. The original 25 acre site is still intact. The site was used by the RAF from 1953 to 1963. It was then used by the US air force until 1979. It was subsequently refurbished as an MOD communications centre and was kept by the MOD until 1999.

1953 – 1963 RAF then - 1979 USAF. Refurbed mid-80s as a comms centre.

Mr Fleming is looking to use the site for educational projects and heritage days. There may be potential for guided tours of the site for small groups. He does not envisage developing the site as a tourist attraction.

Mr Fleming is keen to involve local individuals and groups in development of the site, and he is seeking funding for developments.

Emergency Road closure at Whistleberry 23/04 – 01/05

The emergency road closure at Whistleberry was for utilities works.

The 40 mph speed limit at the junction of the A90 / A92 / A957 will be policed over the next period.

Callum Cheshire noted that the size of 40 mph signs at this junction may not be in accordance with relevant standards.

### **Catterline Braes**



- Funding awarded from the St John's Hill Wind Farm Community Fund, for GCU to assist CBAG to investigate and remediate the two most recent landslips (Apr 2024 and Jan 2025)
- However, the funding award is subject to CBAG having public liability insurance in place
- Quotation received for £78.99, which includes personal accident insurance
- Given the relatively low cash reserves in the CBAG bank account (£363.92), CBAG would like to request the CC to consider (part) funding the purchase of the insurance, either from CC funds or from the Upper Criggie fund

The meeting approved payment for insurance from the Upper Criggie funds.
